### PERSONAL DATA PROTECTION LAW NO.6698

#### RELATED PERSON APPLICATION FORM

Personal data owners defined as "relevant person" (will be referred to as the "**Applicant**") in the **Law on the Protection of Personal Data No. 6698** (will be referred to as "**KVKK**") are given the following rights within the scope of Article 11 of the KVKK:

- Learning whether your personal data is processed or not,
- If your personal data has been processed, to request information regarding this,
- Learning the purpose of processing your personal data and whether they are used appropriately for their purpose,
- Knowing the third parties in the country or abroad to whom your personal data has been transferred,
- To request correction of your personal data in case of incomplete or incorrect processing and to request notification of the transaction made within this scope to third parties to whom your personal data has been transferred,
- To request the deletion or destruction of your personal data in the event that the reasons requiring its processing disappear, despite the fact that it has been processed in accordance with the provisions of other laws and other legislation related to KVKK, and to request notification of the transaction made within this scope to third parties to whom your personal data has been transferred,
- Object to the occurrence of a result against you by analyzing the processed data exclusively through automated systems.,
- In case you suffer damage due to unlawful processing of your personal data, request the compensation of the damage.
